दूसरे दिन जाब बच्चे कॉपी लेकर पहुँचे तो वही लड़का सीना तानकर खड़ा हो गया—मैडम, मैं अपना निबंध पढ़ना चाहता हूँ। मैडम ने कहा, हाँ बेटा, सुनाओ। और फिर पूरे क्लासरूम में ऐसा निबंध गूँजने लगा . कि खिड़की पर बैठे कौए भी ताली पीटने लगे।

उसने शरू किया: चोर देश की अर्थव्यवस्था की रीढ हैं। चोर अगर न हों तो देश का आधा उद्योग बंद पड़ जाए। मैडम का मुँह खुला का खला रह गया। बच्चों ने सोचा ये तो फँस गया-मैडम जबरदस्त डाँट लगाएंगी। मगर लड़के ने आगे जो तर्क दिए, सुनकर सबकी हँसी छूट गई। सोचिए मैडम, अगर चोर न होते, तो ताले कौन बनाता? तिजोरियाँ किसके लिए बनतीं? गरीब लोहार भूख से मर जाते। गोडरेज जैसा ब्रांड तो पैदा ही नहीं होता। क्लास तालियाँ पीटने लगी।

वो रुका नहीं। बोला-और मकान निर्माण उद्योग देखिए। चोरों ने ही मज़दूरों को रोजगार दिया है। वर्ना कौन इतनी ऊँची-ऊँची दीवारें बनवाता? कौन अपने घर की खिडकियों पर लोहे की सलाखें लगवाता? काँटेदार तार की फैक्ट्री चल रही है तो चोरों का ही आशीर्वाद है। चोर ही अस्पली 'रोजगार मेला' आयोजित करते रहते हैं।
